CORRIGENDUM NO.1

This is with reference to TENDER No. 300454, Dated. 06/06/2023 for supply of **Point of Care Devices (POC) for Screening of Sickle Cell Anaemia** by entering into a R.C (Rate Contract) valid for one financial year ending on 31.3.2024.

The following amendments in the tender may be taken note of prior to submission of bids:

- **1.** Clause No. **2. "ELIGIBILITY CRITERIA"**, Sub clause no. **C (i-v)** "Market Standing of the Product" and under Clause No. **3. B. "Techno-commercial Bid, sub clause x**", both are hereby removed from the Tender.
- 2. Clause No. 2., Sub clause no. G "Production and Sparable Capacity" Pt. No.(i) is modified to be read as below:

The Bidder (Indian manufacturer/Indian Importer) has to submit declaration duly certified by the Chartered Account with UDIN, clearly showing the Annual Production Capacity and Annual Sparable Capacity for Assam for the proposed rate contract period (sparable capacity must be more than estimated annual requirement of Assam mentioned in the bid). The same declaration has also to be submitted in Non-Judicial Stamp paper with the seal sign of the bidder.

- **3.** Clause No. 3(B) (xiii) **Execution of similar contract** is here by removed from the Tender.
- 4. Clause No. 5. "Terms & Conditions", Sub clause no. "Delivery & Inspection" E. Pt. No.(iii) is modified to be read as below:

Purchase Order will be placed on the successful Bidder at the discretion of the AMSCL. If the purchase order quantity is less than 1,00,000 Tab/Cap, or less than 10,000 injections/bottles/tubes/tests) in one supply order or P.O (purchase order), the supplies will be allowed in trade pack where both generic & brand name should be there. However, the label should possess the required logogram & the price should not appear on the label.

For imported products, the approved packaging as per import license & rules there under will be applicable irrespective of order quantity.

The Price may be stroked out and desired labeling and barcoding to be done as per tender requirement.

Revised Technical Specification of POC Devices for Screening of Sickle Cell Anaemia Annexure A (Revised)

Intended use: Rapid test kit for determination of Haemoglobin type in the Whole Blood.

Type of haemoglobin detected: Hb A, HbS.

Principle of the test: Lateral Flow Assay.

Antibody type: Monoclonal Antibody.

Type of Sample: Whole Blood

Type of Result: Qualitative

Buffer: may/may not be present

Time of Result: Result generated time from ICMR is less than equal to 10 mins

Newborn Screening: should be Suitable

Test kit size: 10 test/kit (or) 25 test/kit (or) 50 test/kit

Example:

Pack of 10 test per Kit should contain 10 tests including 10 lancets, 10 alcohol swabs, 10 pipettes

Or

Pack of 25 test per Kit should contain 25 tests including 25 lancets, 25 alcohol swabs, 25 pipettes

Or

Pack of 50 test per Kit should contain 10 tests including 50 lancets, 50 alcohol swabs, 50 pipettes

For the better sustainability of each strip individually can be sealed in a test pouch.

6. New clause is here by incorporated as: 2(E)(ii) and 3(B)(xxiv)

The quoted Kit of the bidder should be validated and approved by any of the ICMR validation center and validated/ approved for use in field by MOHFW, Govt. Of India.
