Sub: Revocation/withdrawal of Firm Debarment Notice vide no-556245/11872, dated 11.03.2025 in compliance with the Judgment and Order dated 02.12.2025 passed by the Hon'ble Gauhati High Court in WP(C)/4231/2025.

Sir/Madam,

In compliance with the Judgment and Order dated 02.12.2025 passed by the Hon'ble Gauhati High Court in WP(C)/4231/2025 (Cadila Pharmaceuticals Ltd. vs. State of Assam & Ors.), the Firm Debarment Notice bearing No. 556245/11872 dated 11.03.2025 issued against your company for default in supply (reference at Pt. 7 above) is hereby revoked.

AMSC had earlier issued the Firm Debarment Notice vide e-File No. 556245/11872 dated 11.03.2025, whereby your firm was blacklisted and debarred from participating in any tender for three (3) years due to alleged non-supply/default in supply of ordered essential drugs.

Whereas, the Hon'ble Gauhati High Court, by its Judgment and Order dated

02.12.2025 in WP(C)/4231/2025, has set aside and quashed the aforesaid Firm Debarment Notice dated 11.03.2025, holding inter alia that the impugned notice suffered from lack of competence/authority and was not in consonance with the principles of natural justice.

Now, therefore, in compliance with the aforesaid Judgment and Order, the Firm Debarment Notice bearing e-File No. 556245/11872 dated 11.03.2025 is hereby revoked/withdrawn.
