With reference to the above, this is to inform you that permission is hereby accorded to your firm to supply the pending quantity of the ordered item against PO: 2020102388242 dated 04-03-2025 name of item: Non-absorbable Polyester Suture 3-0 26 mm, RB, 100 cm, Green, DA within a period of 07 (seven) days (from the date of issue of this letter) with applicable LD Charges in view of the fact that the stock of said item (for which PO were placed to your company) are found low in Govt. health facilities of the state due to your non-supply & as such you are hereby given the last opportunity to complete the pending supply of the above mentioned PO.

Accordingly, the product debarment notice vide order no . 647897/20284, dated 17.11.2025 under reference above at Pt. No. 1 in respect of the above- mentioned item shall be kept in abeyance for the next 07 days' and you are hereby allowed to complete the pending supplies within this 7 days time with applicable LD charges.

However, it is made clear that in case the desired supply will not be completed within the stipulated period of 07 days, the debarment shall automatically come into force again without any further notice.

You are therefore requested to ensure strict compliance within the stipulated timeframe.
