Sir/Madam,

With reference to the subject cited above, your company was debarred by the AMSC Authority (Ref. Pt. 1 above) for failure to complete the required minimum quantity (90% supply).

Further to your request letter (Ref. Pt. 2 above) and in view of the special circumstances—particularly the low stock of the said items in government health facilities across the state due to your non-supply—AMSC granted permission for supply of the pending quantities (Ref. Pt. 3 above) vide letter No. 549840/20794, dated : 28.12.2025. Your company has now completed 100% supply of the mentioned items.

The Authority has decided to grant a one-time, case-specific relaxation. Accordingly, the Firm debarment imposed vide Order No. 549840/20012, dated 13.11.2025 (Ref. Pt. 1 above) stands **revoked and withdrawn with immediate effect**.
