Sir/Madam,

With reference to the subject cited above, it is to inform you that, AMSCL had sent intimation on dated 23.08.2024 and 30.09.2024 due to declaration of NSQ batches of **Telmisartan Tablets IP 40 mg having Batch no. LMT240502 and LMT240528, manufactured by M/s Life Max Cancer Laboratories respectively (reference at Pt. 1, 2).**

Also, it is to be mentioned that another batch of **Telmisartan Tablets IP 40 mg** having Batch no. **LMT240611** supplied against the P.O. 2020102384040 Date: 14/03/2024 has been declared as ' **Not of Standard Quality**' as per the test report **under reference placed at Pt. 3.**

AMSCL authority found that said drug is essential in nature for needy patients getting treatment in Government health institutions. **Whereas it is found that three batches of a particular item do not comply the quality test.**

Hence, below penal action ,as per tender clause at Pt. Q (under reference at pt. 7) "Penalty/debarment in Case of Quality Failure" will be imposed on your company (as stated below)

2	<p>In case three batches of a particular item supplied by a Firm failed the quality test. (The quality test to be done by Any Government or empaneled NABL accredited lab)</p>	<ul style="list-style-type: none"> • Product debarment: In addition to above penalties, the Firm shall be debarred from participation in any tender floated by the TIA for 5 years from the date of issue of letter of debarment for that item. • Forfeiture of Performance Security: In addition to product debarment the entire performance security deposited by the supplier for that particular item shall be forfeited and apportioned towards financial penalty. • Alternative Purchase Clause will also be applicable as mentioned in the tender.
3	<p>Where the supplier has framework agreement for three (3) or more items and debarred for a minimum of three items.</p>	<ul style="list-style-type: none"> • Firm Debarment: The firm shall be blacklisted and debarred from participating in any tender for any item(s) issued by the TIA for 3 (three) years from the date of intimation. • Forfeiture of Performance Security: In addition to firm debarment the entire performance security deposited by the supplier shall be forfeited and apportioned towards financial penalty. • The supplier shall not be entitled to any payment for the quantity supplied from that particular batch which was declared NSQ subsequently, irrespective of the fact that the item has been consumed partially. • Penalty @ 5% of the total value of NSQ item will be levied. In case no pending dues are to be paid the amount may be recovered personally from the supplier or from his properties, as per rules. • Alternative Purchase Clause will also be applicable.

Hence, in the greater public & patient interest, your company "M/s Life Max Cancer Laboratories Limited" is hereby debarred for 5 years firm participating in any tender issued by the Tender Inviting Authority (TIA) for that Item i.e. Telmisartan Tablets IP 40 , as per referred tender clause at Pt. Q from the date of issuance of this letter.
