Sir/Madam,

With reference to the above, AMSCL previously notified M/s Healers Lab regarding the declaration of Telmisartan Tablets 40 mg (Batch NosTLL-503, TLL-504 and TLL-507) as Not of Standard Quality (NSQ) by the Government Analyst, RDTL, Guwahati. A show cause notice was also issued on 23/07/2025 regarding the debarment of this product due to the quality failure of these batches.

Further, two additional batches of Telmisartan Tablets 40 mg (Batch Nos. TLL-505 and TLL-510) have also been declared NSQ by the same authority. Consequently, a total of five batches of this product have been identified as Not of Standard Quality by the Government Laboratory.

Telmisartan Tablets 40 mg is an essential drug for patients receiving treatment in government health institutions. The failure of three batches to meet quality standards violates the tender clause Pt Q, "Penalty/Debarment in Case of Quality Failure," which mandates product debarment if three batches of an item fail quality testing.

Therefore, in the greater public and patient interest, your company M/S Healers Lab is hereby debarred from participating in any tender issued by the TIA for Telmisartan Tablets 40 mg for a period of 3 (Three) years from the issuance of this letter.

Additionally, the following penalties will be imposed as per tender conditions:

- Forfeiture of Performance Security: The entire performance security deposited for this item will be forfeited and applied toward financial penalties.
- Alternative Purchase Clause: This clause will be enforced as stipulated in the tender.
