Sub : Product Debarment Notice for default in supply/ non supply of ordered drug Ascorbic acid (Vitamin C) Tablet 500 mg and Ciprofloxacin Tablet 250 mg.

4. Notice cum extension was served to your company vide letter no: (Vide Letter No.571194/6093) on dated- 03.11.2024 to execute the supply within 10 days but your company didn't complete the supply of "Ascorbic acid (Vitamin C) Tablet 500 mg" and Ciprofloxacin Tablet 250 mg" till date.

5. Show Cause Notice Vide Letter No. 571194/7408 for default in supply of "Ascorbic acid (Vitamin C) Tablet 500 mg and Ciprofloxacin Tablet 250 mg having PO vide No. i) 2020102384250, Date : 26-06-2024 ii) 2020102384308, Date : 26-06-2024 was served to " Relief Biotech Pvt. Ltd." on dated : 11.12.2024.

Sir/Madam,

With reference to the subject cited above, it is to inform you that your company was awarded with the Purchase Orders vide PO No. i) 2020102384250, Date : 26-06-2024 ii) 2020102384308, Date: 26-06-2024., for supply of "Ascorbic acid (Vitamin C) Tablet 500 m g and Ciprofloxacin Tablet 250 mg" against your FRAMEWORK AGREEMENT with AMSCL vide tender under reference at Pt.1 (above).

But unfortunately, you didn't start any kind of supply within the contractual delivery period (75days from placing of PO) and period with highest late delivery charges has also crossed i.e., @2% of the value of delayed goods per week of delay or part thereof subject to a maximum of 10% of the total order value (110 days from placing of PO).

Several reminders were sent to your company over phone as well as via official mails for completion of supply, but supply not yet even started.

AMSCL Authority found that said items are essential in nature for needy patients getting treatment in Govt. Hospitals of the state, but your non supply resulted non availability & resulted in increase in out- of-pocket expenditure.

Therefore, your company was served notice as well as additional time to complete the supply vide notice under reference above at pt. no.4 & 5. But in spite of additional time period for completion of supply, your company not even start any kind of supply.

Hence, a show cause Notice Vide Letter No. 571194/7408 on dated : 11.12.2024 was served to your company "Relief Biotech Pvt. Ltd." for default in supply/ non supply of "Ascorbic acid (Vitamin C) Tablet 500 mg and Ciprofloxacin Tablet 250 mg having PO vide No. i)

2020102384250, Date : 26-06-2024 ii) 2020102384308, Date : 26-06-2024. But inspite of show cause notice, neither you have replied anything nor start any kind of supply. Details of delivery status as on date as per DVDMS portal are enclosed at Annexure-A with this letter for your reference.

Non supply of ordered essential drugs resulted hindrance in public service and patient are hereby deprived from Govt scheme of Free Drug Services in Govt Health facilities of the state. Hence, in the greater public & patient interest, your company "Relief Biotech Pvt. Ltd." is hereby disqualified to participate in the tender of AMSCL for a period of 5 years for items "Ascorbic acid (Vitamin C) Tablet 500 mg and Ciprofloxacin Tablet 250 mg" as per referred tender Clause No.5, Sub Clause-H, Pt.no.(i)"Product Debarment.

In addition to the product debarment, the PBG (Performance Security Deposit) will be forfeited for the said drug if submitted or the value of the PBG (Performance Security Deposit) will be deducted from either any of your outstanding bills or any performance security deposited with in department.

Also, please be noted that in the event of making alternative purchase, Clause 5, Sub clause M "Alternative Purchase" you will be imposed with excess expenditure over and above contracted prices incurred in making such purchases and will be recovered either from the Security Deposit or from any other money due/outstanding payment and in the event of such amount being insufficient, the balance will be recovered personally from your company.
